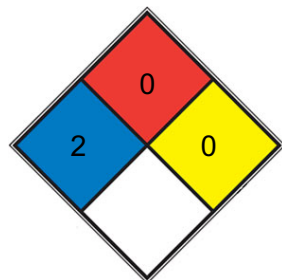

Waste treatment methods
