## SECTION 4: First aid measures

### **Description of first aid measures**

#### **General advice**

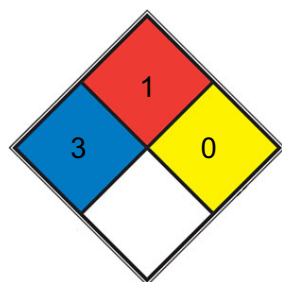
### **Advice for firefighters**
