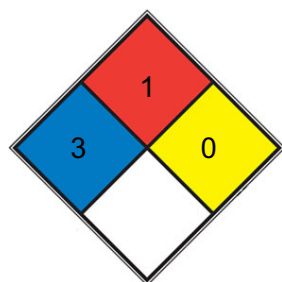

Skin protection
