Carbon oxides

Vapors are heavier than air and may spread along floors. Forms explosive mixtures with air at elevated temperatures.

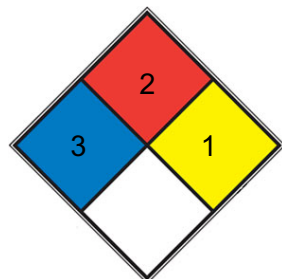
Advice for firefighters

SECTION 6: Accidental release measures
