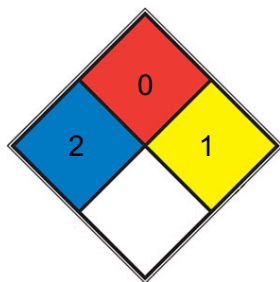

## Waste treatment methods

### Product
