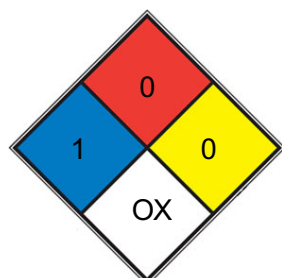

Waste treatment methods**Product**

Contact with sulfur powder and finely divided metals can form shock-sensitive compounds.
