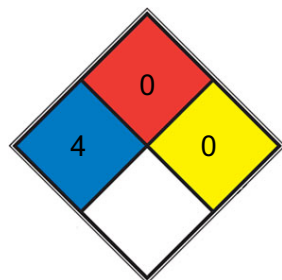

Finely divided powder is highly flammable. Reacts with strong acids and strong oxidizers, chlorine, fused ammonium nitrates, iodine pentafluoride, and nitrosyl fluoride.

Dissolve in a minimum amount of concentrated HCl. Dilute with water until precipitate is formed. Redissolve in HCl. Then saturate with H<sub>2</sub>S. Filter, wash, dry and return to supplier.
