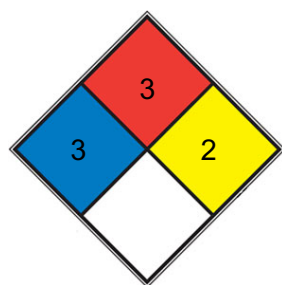

### Body Protection
