#### General advice

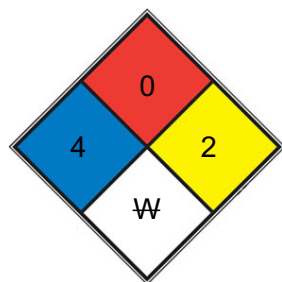
