#### **General advice**

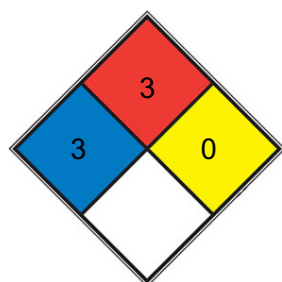
### Advice for firefighters
