## SECTION 4: First aid measures

### **Description of first aid measures**

#### **If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately.

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature.

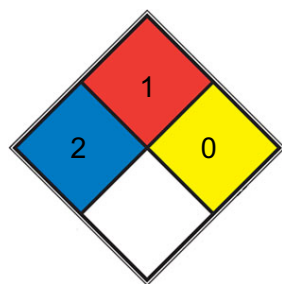

## SECTION 6: Accidental release measures

## Toxicity

Toxicity to fish: LC50 - *Cyprinus carpio* - 54 mg/L - 96 h.

Toxicity to daphnia and other aquatic invertebrates: EC50 - *Daphnia magna* - 45 mg/L - 48 h.

## Persistence and degradability

AEROBIC: Biodegradation data specific to jasmone were not available(SRC, 2015). However, jasmone belongs to the terpene-terpenoid class of compounds(SRC), and results of biodegradation screening tests for a wide variety of terpene compounds indicate that terpene compounds similar to jasmone are biodegradable with degradation classified as inherently to readily biodegradable(1-3).

## Bioaccumulative potential

An estimated BCF of about 100 was calculated in fish for jasmone(SRC), using an estimated log Kow of 3.55(1) and a regression-derived equation(1). According to a classification scheme(2), this BCF suggests the potential for bioconcentration in aquatic organisms is moderate, provided the compound is not metabolized by the organism(SRC).

## Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of jasmone can be estimated to be 295(SRC).

According to a classification scheme(2), this estimated Koc value suggests that jasmone is expected to have moderate mobility in soil.

## Disposal methods

### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
