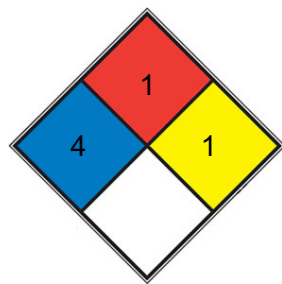

Skin protection
