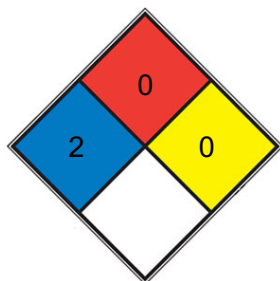

##### **Eye/face protection**
