### Description of first aid measures

#### If inhaled

Quinone is readily absorbed from gastroenteric tract & sc tissues. it is partially excreted unchanged; but bulk is eliminated in conjugation with hexuronic, sulfuric, & other acids. 1,4-benzoquinone

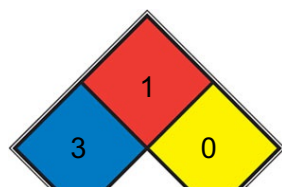

### **Persistence and degradability**

Raw wastewater samples from the petroleum refining industry (containing concentrations of <1 to 4 ng/g 2-methyl-1,4-benzoquinone), were not biodegraded following activated sludge treatment (unreported method detection limit)(1).

### **Bioaccumulative potential**

An estimated BCF value of 2 was calculated for 2-methyl-1,4-benzoquinone(SRC) using an experimental log Kow of 0.72(1) and a recommended regression-derived equation(2,SRC). According to a suggested classification scheme(3), this BCF value suggests that bioconcentration of 2-methyl-1,4-benzoquinone in aquatic organisms will not be an important fate process(SRC).

### **Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the Koc for 2-methyl-1,4-benzoquinone can be estimated to be about 2(SRC). The Koc of 2-methyl-1,4-benzoquinone is estimated as approximately 60(SRC), using an experimental log Kow of 0.72(2) and a recommended regression-derived equation(3,SRC). According to a suggested classification scheme(4), these estimated Koc values suggest that 2-methyl-1,4-benzoquinone has high to very high mobility in soil(SRC).

### **Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
