To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

After absorption:

We have no description of any toxic symptoms.

The following applies to aromatic amines in general: systemic effect: methaemoglobinaemia with headache, cardiac dysrhythmia, drop in blood pressure, dyspnoea, and spasms, principal symptom: cyanosis (blue discolouration of the blood). Under given conditions, contact with nitrites or nitric acid can lead to the formation of nitrosamines, which have shown themselves to be carcinogenic in animal experiments. Other dangerous properties can not be excluded.
