

can result several hours post ingestion. Severe hypotension develops secondary both to decreased contractility from a toxic cardiomyopathy

and to inappropriately low peripheral vascular resistance. Laboratory abnormalities include thrombocytopenia, moderate hepatorenal Chemical Book dysfunction, and elevated serum kinase levels., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
