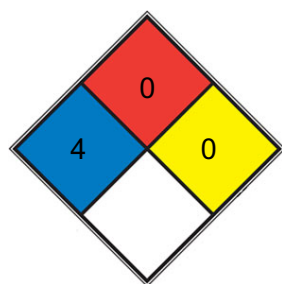

Skin protection

SECTION 13: Disposal considerations

Waste treatment methods

Product

Dissolve or mix the material with a combustible solvent and burn in a chemical incinerator equipped with an afterburner and scrubber. Incompatibilities

Acetylene, ammonia, and hydrogen peroxide (H₂O₂). Contact with moisture, CO₂, acid and acid fumes release hydrogen cyanide. Contact with fluorine is violently explosive at normal temperatures. Incompatible with phosphorus cyanide.
