#### General advice

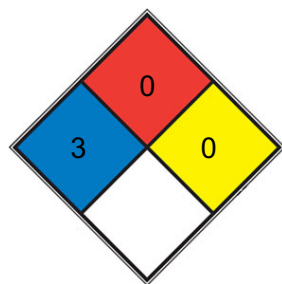
