## SECTION 4: First aid measures

### Description of first aid measures

#### General advice

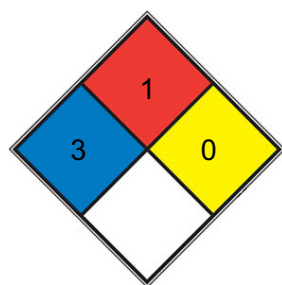
## Advice for firefighters
