Avoid formation of dust and aerosols.

Store in cool place. Keep container tightly closed in a dry and well-ventilated place. Never allow product to get in contact with water during storage.

Dispose of contaminated gloves after use in accordance with applicable laws and good laboratory practices. Wash and dry hands.
